

Path Pre Release Information April 28th, 2023

The Path Release is scheduled for production on **May 21st, 2023**. Included in the release are the featured updates and enhancements outlined below.

- Major enhancements to the functionality and user interface of the *Lock Verification, Request,* and *Confirm* screens, including:
 - More logical organization of loan and lock data.
 - Ability to switch OB lock to manual lock.
 - Ability to revert a lock back to its initial status.
 - Automatic synchronization of loan and lock data.
- Updates to pricing enables:
 - The buy-side base price to auto-populate when a program template is selected on the loan side.
 - The lock price to auto-populate when a program template is selected on the lock side.
 - Product and pricing data to auto-populate on the *Lock* screens when that data is obtained from a program template.
- New navigation bar, which lays out the architectural hierarchy within Path.
 - Starting from left to right, each level is represented by a dropdown menu, which gives users access to everything within that level.
 - 1st level: *Loans, Sandbox, Configuration,* and *Settings*.
 - 2nd level: Current and previously opened loans, *Pipeline, Reports,* and *Trades*.
 - 3rd level (activities): Production, Lock, Compliance, Conditions, Documents, Checklist, Interfaces, and Messages.
 - 4th level (screens): Borrower, Product & Pricing, Transactions, Property, Closing Costs, Loan Transmittal, etc.

HUD – MIP Rate Change Notification March 1, 2023

On Feb 22, 2023, HUD notified the industry that the MIP rates will change effective March 20th, 2023.

As workaround, please use the lock icon of **the Premium %** field to edit both the **Premium %** field and the **Renewal 1** field (Product & Pricing screen > Mortgage Insurance section). Click this icon to unlock both fields (make them editable), where you can manually enter the new MIP rates. This update is scheduled for March 5th.
